## **Saul Centers, Inc. Announces Tax Treatment of 2007 Dividends**

BETHESDA, MARYLAND - Saul Centers, Inc. (NYSE: BFS), an equity real estate investment trust (REIT), announced today the income tax treatment for its 2007 dividends. The Company declared and paid four quarterly dividends totaling \$1.77 per share of Common Stock during 2007. For tax purposes, 100.0% of the dividends (\$1.77 per share) are characterized as ordinary income. The Company declared and paid four dividends totaling \$2.00 per depositary share of its 8% Preferred Stock during 2007. For tax purposes, 100.0% of the Preferred Stock dividends are characterized as ordinary income. The information will be reported to shareholders on Form 1099-DIV.

Saul Centers is a self-managed, self-administered equity real estate investment trust headquartered in Bethesda, Maryland. Saul Centers currently operates and manages a real estate portfolio of 48 community and neighborhood shopping centers and office properties totaling approximately 8.0 million square feet of leasable area. Over 80% of the Company's cash flow is generated from properties in the metropolitan Washington, DC/Baltimore area.
